

This is an extremely compact Zigbee 3.0 single-channel neutral wire switch, capable of being installed in a mounting box and supporting a maximum load of 10A, thus making ordinary switches smart. It supports a repeater function to easily improve Zigbee communication quality and can also link with other devices in smart scenarios to realize your home automation.



1) Button

- Single press: Turn on/off the smart device.
- Press and hold for 5 seconds: Device enters the pairing mode. (Pairing time 10 minutes)
- Click three times in succession: Switch the external switch type.

First-time power on/Device is in pairing mode.

- Steady on: Normal connection with the gateway.
- Slow flash: The device is in pairing mode.
- Fast flash: Abnormal connection with the gateway.
- Flashes three times quickly: Switch the external switch trigger type.

2. Wiring instruction










- ① It is prohibited to connect S1 and S2 terminals to the neutral or ground wire, in order to avoid damaging the equipment and causing danger.
 - 2 Make sure all wires are connected correctly.
 - 3 Supported switches are rocker switch and push button and factory default by supporting rocker switch.

Method of changing the switch type: short press the button 3 times until the green indicator flashes 3 times quickly, now you change the switch type successfully.

Factory Reset

Trigger conditions (any one condition met)

- Press and hold the device button for 5 seconds.
- ITEAD 陈晓君(12892263) • Quickly press the external switch 10 times (except for the external switch type, all other settings will be restored to factory defaults).
- Delete the device on eWeLink.

To ensure the safety of your electrical installation, it's essential either a Miniature Circuit Breaker (MCB) or a Residual Current operated Cicuit-breaker with Integral Overcurrentprotection(RCBO) with an electrical rating of 10A has been installed before the ZBMINIR2.
